Highlights of Redevelopment Exhibition

Thane Federation is having Membership of about 16,000 Co-operative housing societies in Thane District. We are expecting heavy 10,000 participates for to attend the said conference. We are also holding a Exhibition at venue place.

At present, the state has around 1.25 lakh housing societies and 40,000 of these are likely to go for redevelopment. In Mumbai, over 20,000 housing societies can opt for redevelopment.

"With many old housing societies expressing interest in redevelopment, the concern was mainly to find the right architects, project management consultants, certified auditors and chartered accountants. Who will protect and safeguard the interest of Housing societies said Sitaram Rane, Chairman of the federation.

As per the new redevelopment rules, a housing society would need consent of 51% of the total members for the redevelopment. Earlier, approval from 70% of members of a housing society was mandatory for the process.

Mumbai, Pune, Navi Mumbai and Thane are four cities in Maharashtra, where decades-old housing societies were suffering because of crumbling infrastructure and lack of funds for redevelopment. But with the changes in redevelopment rules, these housing societies can go for redevelopment without any delay and additional premium.
